Almond Industry Update - March 2024

In August of 2023, almond prices fell to a 20-year low due primarily to concerns over large ending stocks. The benchmark prices for standard almonds were indicated at \$1.40 per pound, the lowest price for the benchmark since January 2003. The historically low prices were fueled by market perception that supply would continue to outweigh demand with an expectation of carry in stocks close to 800 million pounds and a higher-than-expected USDA Objective Almond Measurement of 2.60 billion pounds, placing total supply north of 3 billion pounds for the 2023/24 marketing season.

Almond pricing is cyclical in nature, as demonstrated by the chart to the right, reporting the past 25 years of pricing for conventional almonds. Peak pricing in 2005/06 and again in 2014/15 were both followed by severe declines of 27% and 22%, respectively. The beginning of price recovery was evident five years after the 2005/06 spike, with a steady ascent to record-high prices of \$4.00 per pound. However, prices have reflected a continued decline following the 2014/15 spike. Pricing below \$2.00 per pound for the last three crop years, coupled with substantial increases in farm input prices, and higher interest rates pose significant challenges for the almond industry.





Almond prices increased slightly in December 2023 and January 2024 due to strong shipments; however, have softened in recent weeks as a result of a slight decline in February shipments, positive bloom conditions despite occasional rain and strong winds, and early projections for a large 2024 crop.

According to the Almond Board of California, shipments for the month of February were 221 million pounds reflecting a 6% decrease from the previous month and a 10% decrease from the record shipments in February of 2023. Export shipments, which had shown strength over the past four months, declined slightly to 162 million pounds, down 14% compared to the prior year. Domestic shipments reached 59 million pounds, up 2.3% compared to the prior year. Despite some monthly fluctuations, total shipments over the first seven months of the marketing year were 5.6% ahead of the prior year. Based on shipments to date, the industry appears on track for a carry-out in the range of 500 million pounds.

While opinions for a potentially large 2024 crop are currently causing softness in almond prices, favorable early growing conditions may be offset by lower-than-expected carry-out projections and potential grower input cutbacks driven by the current economics of the industry. However, it is still too early to begin forecasting the potential crop size.

The U.S. Department of Agriculture's (USDA) National Agricultural Statistics Service (NASS) recently announced the results of the 2022 Census of Agriculture, spanning more than 6 million data points about America's farms and ranches and the people who operate them down to the county level.

Some highlights from the Fresno and Madera County reports include:

- 90% of farms in Fresno County are family farms.
- The top crops in Fresno and Madera counties by acres are: almonds, grapes, pistachios, vegetables, forage/hay, and corn for silage.
