### JOB DESCRIPTION

Fresno Madera Farm Credit is searching for a self-motivated, highly driven individual to join our fast-paced team environment. The Associate Credit Analyst assists the Credit Support Team with loan processing, while performing non-complex loan underwriting. The intent is to provide support in all areas of credit administration such as: processing loans for underwriting, underwriting small/quick loans and non-complex loans. In addition, this role will be responsible for verifying accurate information in the loan software application.

### Loan Process

1. Enters information into loan software system for loan origination.
2. Coordinates efforts with Legal department by answering questions, preparing documentation and meeting with Legal to review information.
3. Orders Appraisal, Fieldwork & Title Reports.
4. Processes loan pricing requests.
5. Verifies accuracy of data entered.

### Quick Loan Processing

1. Determines eligibility based on defined criteria.
2. Input QL information into loan software system.
3. Identifies issues and determines if additional analysis is required.
4. Prepares files for approval if credit score is within designated authority level.

### Loan Underwriting

1. Assesses creditworthiness of borrowers.
2. Prepares credit reports that summarize findings/risks.
3. Recommends and votes on loan applications.
